SUB : Census of India, 2011 – Payment of contingencies to the Charge Officers-reg.

PREAMBLE

The Registrar General of Census, Government of India, New Delhi in its letter Read (1) has sanctioned an amount of Rs. 1,93,44,600/- (One crore ninetythree lakhs, fortyfour thousand six hundred rupees only) towards contingent expenses for miscellaneous items required for imparting training to Enumerators and Supervisors viz hiring of halls, Public Address System, Overhead projectors, LCD projectors, Local Publicity, Local Transportation of census material, Stationary, Xerox charges, Manpower for shifting and packing materials, postal charges, FAX/Telephone charges etc., for conduct of both Houselisting and Housing Census and Population Enumeration of Census 2011.

The Registrar General of Census, Government of India, New Delhi in its letter Read (2) has sent a cheque bearing No. 100726 dt. 16-3-2010 for Rs. 1,93,44,600/- (One crore ninetythree lakhs, fortyfour thousand six hundred rupees only) to the Accountant General, Karnataka, Bangalore. The Accountant General on receipt of cheque will credit the amount to a new sub head “8443-00-800-0-01 Deposits of payment of honorarium to the Enumerators/Supervisors in Census 2011” and the Government of Karnataka, will afterwards release the amount to the charge officers and to all the Deputy Commissioners . Hence this order.


