

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: Payment of Honorarium to the field functionaries in connection with the work of National Population Register (NPR) for the country.

Preamble:

The Registrar General and Census Commissioner, India, New Delhi in letter read at (1) & 2 above and the proposal sent by the Director of Census Operations Karnataka, Bangalore read at (3) above have conveyed sanctioned for payment of honorarium to the Enumerators, Supervisors and Other Census functionaries appointed in connection with the work of National Population Register (NPR) for the country.

The rates of honorarium payable to the Enumeration staff and the other Census Functionaries are mentioned below:

1	Enumerator & Supervisor	Rs. 3000/-	i. Rs. 1500/- for filing up of NPR Household Schedules, Enumerators Abstract etc. in connection with Enumeration blocks. ii. Rs. 1000/- for first round of collection of biometrics. iii. Rs. 500/- for second round of collection of biometrics.
2	Master Trainers	Rs. 1100/-	For imparting training to Supervisors and Enumerators.
3	Local Registrar	Rs. 4000/-	All work relating to NPR including training, data collection, collection of biometrics, publication of LRUR, Verification / Authentication of the same, finalization of LRUR within her/ his jurisdiction.

- 2. The above approval is subject to the following stipulation :-
- Enumerators and Supervisors kept in reserve, who attend training only, and the enumerators and supervisors, who attend training but do not undertake field work of NPR 2011 shall not be eligible for honorarium;
- ii. Enumerators and Supervisors, who could not associate with all the phases of creation of NPR due to some reasons or other, but completed first phase and/ or second phase and/ or third phase as the case may be, shall be eligible to get honorarium at the rates indicated in column 4 [row 1] of the table above;
- iii. Other NPR functionaries i.e., Local Registrar, Charge Officer, Sub-district Registrar, District Registrar and State Coordinators, who could not associate with all the phases of creation of NPR due to some reasons or other shall be given the honorarium on the proportionate basis in accordance with the remuneration fixed at Column 3 [row 3 to 7] above;
- iv. The Honorarium to Enumerators/Supervisors and NPR functionaries would be admissible only after getting a certificate to the effect that they have successfully completed the assigned work in connection with creation of NPR.

The Proposal of Director of Census Operations Karnataka, Bangalore has been examined and following orders are issued.

The Registrar General and Census Commissioner, India, New Delhi will be releasing the honorarium amount at the rates detailed below to each Enumerators, Supervisors and Other Census functionaries in due course after receipt of this funds may be disbursed to the Enumeration staff.

The Head of Municipal Corporations and other urban bodies are requested to prepare the bill and get the counter signature of concerned Deputy Commissioners and to submit the same to the concerned Treasury for encashment.

The Deputy Commissioner will furnish consolidated expenditure statement for the amount drawn and disbursed by them to the Directorate of Census Operations, Karnataka, Bangalore and to the Secretary, Revenue Department (Disaster Management), Bangalore every month regularly.
