Sub: Organization of Census of India 2011 – Constitution of a State Level Census Co-ordination Committee – reg.

READ : D.O. Letter No.CEN/7/ORG/2009 dated 15th October, 2009 of the Director of Census Operations, Karnataka, Bangalore.

PREAMBLE :

The Director of Census Operations, Karnataka Bangalore has in his letter read above has stated that the 2011 Census in the state will be conducted in 2 phases viz. during the Houselisting & Housing Census in April, 2010 and the Population Enumeration during February-March, according to a time schedule on a war footing, involving a huge network of activities to be undertaken by the various Departments of the State Government. He has therefore, proposed constitution of a State Level Coordination Committee with a view to ensure coordination among the various departments of the State Government.

Hence the following order.
