

**PROCEEDING OF GOVERNMENT OF KARNATAKA**

**Sub:** CENSUS 2011-Freezing of Boundaries of Administrative Units during the period of the census operations.

**Preamble:-**

1. The Registrar General, India, Ministry of Home Affairs, Government of India, New Delhi has in his letter read at Sl. No.(1) above has intimated that the next decennial Census of India 2011 i.e. housing and house listing census will be conducted all over the country from April 2010 followed by the population enumeration in February-March-2011 and that for the efficient conduct of Census Operations it is essential that the boundaries of the administrative units are not disturbed after the demarcation of the enumeration Blocks till the completion of the census operation. In the context he has conveyed that the Government of India have desired that wherever any changes in the jurisdiction of the present administrative units are found necessary such changes may be given effect to by 31<sup>st</sup> December 2009.
2. The Director of Census Operations, Karnataka, Bangalore further to and following up the request of the Government of India has in his letter read at (2) above has requested that no changes whatsoever are effected in the boundaries of the administrative units during the period 1<sup>st</sup> January 2010 to 31<sup>st</sup> March 2011.

**Government Order No. RD 70 BHUDAPU 2009, Bangalore,  
Dated 24.12.2009**

After consideration of the matter, the Government direct that,

- I. All proposals for making any changes in the boundaries of existing municipalities, revenue villages tahsils, police stations, development blocks, talukas, sub-divisions, district etc. or for forming new units which may be pending or which may be taken up in near future shall be finalized and given effect to by 31<sup>st</sup> December 2009

- II. Thereafter that no changes repeat no changes whatsoever such as the above shall be made in the administrative units referred to above till the completion of the 2011 Census Operations i.e., 31<sup>st</sup> March 2011 in Karnataka.
- III. The Government further direct that all changes relating to the administrative units if any, be given effect by 31<sup>st</sup> December 2009 and shall be intimated to the Registrar General, India, New Delhi and also the Director of Census Operations, Karnataka, Bangalore.
